**Advocacy and Awareness:**

**Policy Development and Implementation:**

Developing and implementing policies, guidelines, and standards related to accessibility, ensuring compliance with relevant regulations, and monitoring the effectiveness of accessibility measures.

**Accessibility Audits and Assessments:**

Conducting regular audits of buildings, infrastructure, and information systems to identify and address barriers, and providing recommendations for improvements.

**Technical Assistance:**

Providing technical expertise and support to building owners, developers, and designers to ensure compliance with accessibility standards during construction and renovation.
